General Terms & Conditions

Please read these terms and conditions carefully prior to registering to enter the 2 Bent Rods Fishing Challenge. Registering for the 2 Bent Rods Fishing Challenge constitutes your acceptance of these terms and conditions.

1. Eligibility Open to residents of Australia.

Two age groups – 1 major prize, 1 runner up prize in total:

Teen Division: 13–19 years old (as of the start date)

Adult Division: 20+ years old

Competitors under 18 must have parental/guardian consent.

2. Dates

Competition runs from 12:01am **Saturday 16th May 2026** to 11:59pm **Sunday 17th May 2026**. (Qld time). All entries must be submitted before the closing time.

3. Target Species **Tailor** only.

Winner determined by longest combined length of 2 **Tailor**.

4. Prizes

Major Prize: Shimano Stradic valued at \$429 rrp.

Minor Prize (top angler from the non-winning age group): \$50 RRP Prize Pack

5. Measuring & Photo Requirements

a. Fish must be alive when photographed and released immediately after measuring (unless kept within legal limits).

b. The official competition code must be clearly visible in the photo. Cannot be added digitally. (Code will be emailed and texted to entrants)

c. Fish must be laid flat on a brag mat or measuring board with:- Nose touching the 0 cm mark-

d. Measurement taken from the nose to the tip of the tail- tail spread

e. Entire fish visible in the photo

f. Measurement clearly readable

g. Photos must be taken from directly above, showing the whole fish.

h. Edited or manipulated images will result in disqualification.

i. Any requirement not followed will result in disqualification of the fish.

6. Winner Selection

One winner will be selected from eligible entries for the species category: In the event of a tie, the entrant who submitted all 2 of their fish first will be the winner. If nobody catches 2 fish of that species, the winner will be determined by the next longest fish.

8. Rules of Fishing

All competitors must comply with local fisheries regulations, including size and bag limits.

Any fish caught outside legal requirements will be disqualified.

Only fish caught during the competition period are eligible.

9. Submission of Entries

All entries must be submitted via the 2 Bent Rods app.

Measurement length in mm

Late or incomplete submissions will not be accepted.

10. Fishing Licences

If required by your local state or territory laws, you must hold a valid fishing license as you're your state or territory regulations. Competitors may be asked to produce proof of the license before prizes are awarded.

11. Judging

Scores are based on the combined length (mm) of the two longest target species. All photos are score-checked by the judges for correct measurement and photo code. Judges' decisions are final — no correspondence will be entered into.

12. Conduct

Competitors must conduct themselves in a fair and sportsmanlike manner. Any evidence of cheating, rule violations, or unethical behaviour will result in disqualification.

13. Refunds

Refunds will not be given for unseen weather conditions, Competitor work commitments, Competitor sporting commitments or change of mind.

Refunds will be issued to the original payment method.

In certain circumstances, we reserve the right to cancel a refund if new information emerges that proves the customer's claim invalid.
